No. 12/5/2010-4492/1694 whereas it appears to the Governor of Punjab that to meet the challenge of rapid growth of Patti Town and to provide for a workable framework for comprehensive planned and regulated development preparation of statutory Master Plan of Patti Town is very essential. Hence in order to develop Patti Town and its surrounding in an orderly manner and to prepare its Master Plan under the "The Punjab Regional and Town Planning and Development Act, 1995" the Governor of Punjab is pleased to declare the Local Planning Area of Patti Town within the meaning of sub section (1) of section 56 of the Punjab Regional and Town Planning and Development (Amendment) Act, 2006. The total area proposed for Local Planning Area is 51849 hectares including 96 villages and one municipal council Patti. The schedule of boundary of Local Planning Area is given below:

SCHEDULE OF BOUNDARY

North:

Starting from point 'A' which is the common meeting point of village Lakhna (H. B. No. 229) Village Sugga (H. B. No. 143) and village Gulatipur (H. B. No. 228) & moving towards east along the Northern boundaries of village Begepur (H. B. No. 233), Tapa (H. B. No. 230) Baragari (H. B. No. 231) Ahmedpur (H. B. No. 167), Jamalpur (H. B. No. 257), Uboke (H. B. No. 256), Kairon (H. B. No. 285), Nathuchak (H. B. No. 254), Lauhka (H. B. No. 253) Lauhka (H. B. No. 253), Jawanda Kalan (H. B. No. 262), Naushehra Pannuan (H. B. No. 269), Ussma (H. B. No. 268) and Rakh Sheron (H. B. No. 267) upto point 'B' which is the common meeting point of village Rakh Sheron (H. B. No. 267) Banwalipur (H. B. No. 103) and Village Dugari (H. B. No. 104).

East:

Thence starting from point 'B' towards South along the Eastern boundaries of Rakh Sheron (H. B. No. 267), Ussma (H. B. No. 267), Nausehra Pannuan (H. B. No. 269), Kisangarh (H. B. No. 273), Bhatal Bhaik (H. B. No. 272), Waryah (H. B. No. 280), Mohampur (H. B.

No. 278), Chohla Sahib (H. B. No. 304), Ruriwala (H. B. No. 302), Chamba Kalan (H. B. No. 354), Gandiwind (H. B. No. 298), Kambo Dhaliwala (H. B. No. 355), upto point 'C' where South-Eastern boundary of village Kambo Dhaliwala (H.B.No.355) meet with common boundary of district Tarn-Taran and Ferozepur.

South:-

Thence starting from point 'C' moving towards west along the common boundaries of District Tarn-Taran and Ferozepur upto point 'D' where South-Western boundary of village Mallahanwala (H.B.No. 351) meet with common boundary of District Tarn-Taran and Ferozepur.

West:-

Thence starting from point 'D' towards north along the Western boundaries of village Mallahan wala (H. B. No. 351), Sabhroan (H. B. No. 190), Saido (H. B. No. 160), Umra Bath (H. B. No. 162), Boparai (H. B. No. 155), Dhariwal (H. B. No. 154), Paryagpura (H. B. No. 153), Akbarpur (H. B. No. 152) and Dialpur (H. B. No. 149) Bur Chand (H. B. No. 148), Bhaini Gurmukh Singh (H. B. No. 147), Patchpur Sugga (H. B. No. 144) and Village Lakhwa (H. B. No. 229) upto the point 'A' which is the starting point.

The boundaries of Local Planning Area, Patti are specifically shown on the Drawing No. DTP (Asr) 12/2010 Dated 5-5-2010. All the provisions laid down u/s 56 (2) of "The Punjab Regional and Town Planning Development (Amendment) Act, 2006 and all the concerned rules framed under this Act have been taken into consideration.
